At the locations indicated, amend the substitute amendment as follows:

1. Page 8, line 1: before that line insert:

"SECTION 1. 5.02 (1w) of the statutes is created to read:

5.02 (1w) "Conform," when used with reference to the name of an individual that appears on proof of identification, includes, but is not limited to, a substantially similar name, a nickname, initials substituted for the first or middle name, a misspelled name, a shortened or informal form of a name, a slightly erroneous version of a name, a name that appears to contain a transposition error, and a name that includes or excludes a suffix or hyphenation that should or should not appear."

2. Page 8, line 1: delete "SECTION 1" and substitute "SECTION 1m".
