**ASSEMBLY AMENDMENT,  
TO 2011 ASSEMBLY BILL 2**

The material beginning with "zones"  
and ending with "areas" on line 4

1 At the locations indicated, amend the bill as follows:

2 <sup>fix component</sup> → 1. Page 1, line 3: delete (lines 3 and 4) and substitute additional enterprise  
3 "zones, requiring the designation of enterprise zones in rural areas, and transferring  
4 administration of the enterprise zone program".

5 2. Page 2, line 13: after that line insert:

6 "SECTION 4<sup>m</sup> Nonstatutory provisions.

7 (1) Notwithstanding section 560.799<sup>✓</sup> of the statutes, as affected by this act, the  
8 department of commerce shall transfer administration of the enterprise zone  
9 program under section 560.799<sup>✓</sup> of the statutes, as affected by this act, to the  
10 Wisconsin Economic Development Corporation,<sup>✓</sup> during the period beginning on the

effective date of this act and ending on July 1, 2011, or the date on which the biennial

budget bill takes effect, whichever is later.”
