TO 2011 ASSEMBLY BILL 148

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: before that line insert:

3 "SECTION 1m. 20.005 (3) (schedule) of the statutes: at the appropriate place,  
4 insert the following amounts for the purposes indicated:

10 SECTION 1p. 20.505 (4) (da) of the statutes is created to read:

11 20.505 (4) (da) *Extraordinary police services provided to state facilities.* As a  
12 continuing appropriation, the amounts in the schedule to pay for extraordinary  
13 police services provided directly to state facilities under s. 16.008.".

1           **2.** Page 2, line 1: delete “**SECTION 1**” and substitute “**SECTION 1v**”.

2           **3.** Page 3, line 6: after that line insert:

3           “**SECTION 9101. Nonstatutory provisions; Administration.**

4           (1) EXTRAORDINARY POLICE SERVICES PROVIDED TO STATE FACILITIES. Before  
5 expenditure of any moneys appropriated under section 20.505 (4) (da) of the statutes,  
6 as created by this act, the secretary of administration shall report to the  
7 cochairpersons of the joint committee on finance the specific items proposed to be  
8 expended. The report shall specifically include expenditures to reimburse local  
9 governments for police services provided to state facilities. No moneys may be  
10 expended from that appropriation until the proposed expenditure is approved by the  
11 committee.”.
