**SENATE AMENDMENT,**

**TO 2011 ASSEMBLY BILL 148**

1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 6: after that line insert:

3 **"SECTION 9135. Nonstatutory provisions; Natural Resources.**

4 (1c) LOCAL RECYCLING GRANTS. The department of natural resources may not  
5 reduce the amounts available for grants for effective recycling programs under  
6 section 287.23 of the statutes in order to lapse or transfer funds from the  
7 appropriation account under section 20.370 (6) (bu) of the statutes in fiscal year  
8 2010-11. Notwithstanding the deadline for disbursing grants under section 287.23  
9 (6) (a) of the statutes, before July 1, 2011, the department shall fully disburse the  
10 amounts appropriated for fiscal year 2010-11 under section 20.370 (6) (bu) of the  
11 statutes to eligible responsible units as grants for 2011."
