

TO 2011 ASSEMBLY BILL 13**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 3: substitute "Rock County" for "the city of Beloit".

3 **2.** Page 2, line 7: delete lines 7 to 8 and substitute:

4 "560.795 (1) (i) All of Rock County."

5 **3.** Page 2, line 24: after that line insert:

6 "SECTION 3m. 560.795 (2) (d) 2. of the statutes is amended to read:

7 560.795 (2) (d) 2. The department shall immediately notify the local governing
8 body of the city in which the development opportunity zone is located, or the county
9 board of Rock County for the development opportunity zone under sub. (1) (i), of a
10 change in the expiration date of the development opportunity zone under this
11 paragraph."
