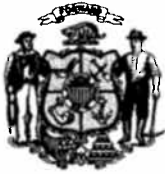

2 1. Page 1, line ~~3~~ ¹⁰: before that line insert:

3 "SECTION 1g. 946.41 (2) (c) of the statutes is created to read:

4 946.41 (2) (c) "Soft tissue injury" means an injury that requires medical
5 attention to a tissue that connects, supports, or surrounds other structures and
6 organs of the body and includes tendons, ligaments, fascia, skin, fibrous tissues, fat,
7 synovial membranes, muscles, nerves, and blood vessels."

8 2. Page 1, line 3: delete "SECTION 1" and substitute "SECTION 1m".
