

- 4 "8. The parent of the pupil and the nonresident school board agree that

- 6 If the resident school board notifies the parent of the pupil who applies under this
- 7 subdivision that the pupil may not attend the nonresident school district, the parent
- 8 may appeal the resident school district's decision to the department and must
- 9 explain in the appeal why the pupil applied to attend school in the nonresident school
- 10 district. The resident school district must respond to the appeal and provide an
- 11 explanation for rejecting the pupil's transfer into the nonresident school district. If
