1 At the locations indicated, amend the bill as follows:

2 **1.** Page 22, line 12: delete "A person" and substitute "Except as provided under
3 subd. 4., a person".

4 **2.** Page 22, line 15: delete "unless subd. 4. applies".

5 **3.** Page 22, line 15: before "The application" insert "The person may not
6 proceed with the discharge unless the person receives authorization from the
7 department.".

8 **4.** Page 23, line 3: delete lines 3 to 9 and substitute:

9 "2m. Within 30 days after an application under subd. 1. is received by the
10 department, the department shall request additional information, shall inform the
11 applicant whether a wetland individual permit will be required as provided in par.
12 (i), or shall authorize the discharge under the wetland general permit.".
