ASSEMBLY AMENDMENT,
TO 2011 ASSEMBLY BILL 463 368

1 At the locations indicated, amend the bill as follows:

2 1. Page 31, line 14: after that line insert:

3 “(cm) Before entering into an agreement with a sponsor of a mitigation bank
4 to establish such a bank or before otherwise approving a mitigation bank, the
5 department shall provide written notice that a mitigation bank may be established.
6 The notice shall be given to each city, village, town, and county in which each
7 proposed mitigation bank site will be located. Each city, village, town, and county
8 receiving the notice shall be given an opportunity to submit comments regarding the
9 establishment of the mitigation bank. The notice shall contain all of the following
10 information:

11 1. The name of the sponsor of the proposed mitigation bank.

12 2. A brief description of the mitigation bank and all of its bank sites.

1 3. A date after which the department will not accept comments from the
2 affected cities, villages, towns, or counties.

3 4. An address to which any comments shall be submitted.”
