

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 18: delete lines 18 to 21 and substitute: "occupational training
3 for claimants who wish to participate in 3 local workforce investment areas under
4 29 USC 2831 designated by the department. The department shall offer the program
5 within the entire area of each designated local workforce investment area."
