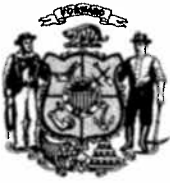

"This does not prohibit the department of agriculture, trade and consumer protection from issuing an order or promulgating a rule under s. 100.20 that construes a statute under this chapter pursuant to its obligation to implement the provisions of the statutes."
