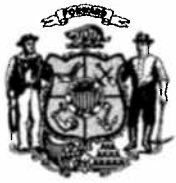
I think that adding the following two provisions would address the concerns raised during today's meeting.

Section 13. 49.475(2m) is created to read:

- (a) Information the department may request under this section is limited to the information identified under sub. (2), and does not include the name of an employer unless this information is needed for the department or provider to receive 3rd-party payment for an item or service.
- (b) In circumstances where the information identified under sub. (2) may be available from more than one source, the department shall seek the information first from an 3rd party administrator or other entity identified under sub. (1)(f)7 or a pharmacy benefits manager before seeking the information from an employer operating under a self-insured plan.

Section 14. This act takes effect 6 months after date of enactment.

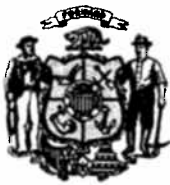
