We had an amendment drafted that was LRBa1670/1. Can we do a /2 with the following language?

“An instructional program under this section shall use instructional methods and materials that do not discriminate against pupils under s. 118.13 (1) based upon the pupil’s race, gender, religion, sexual orientation, or ethnic or cultural background or against sexually active pupils or children with disabilities. Nothing in this section shall be construed to prohibit a school board from approving an instructional program under this section that includes instruction on abstinence from sexual activity or that is abstinence-centered.”
