Hi Tracy,

We are looking to draft a simple amendment to LRB 2088/1 with the following two changes:

-Page 10, regarding the advisory committee: provide an exception so that parents (and only parents) *may* comprise more than 1/5 committee membership.

-Page 10, lines 11 and 12, completely delete the sentence that requires the advisory committee to review the curriculum every 3 years.

(IE, we want the last line of 118.019(5) to be "No more than one quarter of the members of the committee may be made up of employees of the school district or their spouses or members of the school board or their spouses.")

The Senator asked that a rush be put on this amendment. If you need clarification, please let me know. Thanks so much for all of your work, and have a good weekend.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 10, line 4: delete "and no" and substitute "No".

3 **2.** Page 10, line 5: delete "committee." and substitute "committee, except that
4 parents may comprise more than one-fifth of the membership of the committee.".

5 **3.** Page 10, line 10: delete lines 10 (to) 11 and substitute "committee's human
6 growth and development curriculum. The advisory committee shall review the
7 curriculum at least every 3 years.".

Page 10, line 5: delete "one fifth" and substitute "one-fifth"
