

Scott, currently the task force is appropriated \$50,000 for its expenses in the 2011-12 fiscal year. Do you want to appropriate money for its expenses in the 2012-13 fiscal year? As an alternative, you could divide the amount currently appropriated in two and appropriate \$25,000 each fiscal year, or you could make the current appropriation biennial, meaning the task force could spend the \$50,000 anytime during the two-year period. The latter might make more sense, since presumably the task force wouldn't need as much money during the second fiscal year.

By the way, is a reporting date of January 8, 2013, okay? The year starts on a Tuesday, but that's a holiday. Would you prefer Wednesday the 2nd or Monday the 7th?

## ANALYSIS

(2011 Wisconsin Act 32)

The 2011-13 biennial budget act created the special Task Force on UW Restructuring and Operational Flexibilities to study the University of Wisconsin system. The act ~~has~~ appropriated \$50,000 for ~~the~~ task force expenses during the 2011-12 fiscal year and directed the task force to submit its report to the Joint Committee on Finance and other appropriate standing committees of the legislature by January 1, 2012.

This bill delays the reporting deadline until January 7, 2013, and ~~modifies the appropriation~~ <sup>provides</sup> that the amount appropriated may be spent over the 2011-13 fiscal biennium.
