### *Analysis by the Legislative Reference Bureau*

Under current law, a veteran who, while in the active U.S. military service, suffered an injury resulting in a disability that limits or impairs the ability to walk may obtain a registration plate of special design that entitles him or her to certain parking privileges. These plates may be personalized with letters or numbers, not exceeding four positions, chosen by the person to whom the plates are issued.

Under this bill, the plate may be personalized with letters or numbers, not exceeding six positions, chosen by the person to whom the plates are issued.
