Senator King would like to request an amendment to SB 396 identical to the amendment drafted by Rep. Molepske for AB 489. The amendment would change the funding mechanism. In the Harsdorf amendment funds from the Working Lands Initiative are used to back fill GPR to pay for the livestock premises program. The amendment would use JFC discretionary funds (according to Bob Lang there is \$267,000 available at this time) as the funding mechanism.
