Assumptions Used in Arriving at Fiscal Estimate

Assembly Bill (AB) 663 creates a reward system for the reporting of fraud, waste, or mismanagement in state government. The bill directs the Secretary of Administration to pay any reward to the person reporting the fraud, waste or mismanagement from the appropriation account that is used to fund the program that is the focus of the report of fraud, waste, or mismanagement.

It is not possible to determine what reports of fraud, waste or mismanagement will be received, or the amounts that will be paid to the reporting party or the appropriations that will be the source of any reward.

Long-Range Fiscal Implications
