1 AN ACT relating to: increasing the funding for grants to provide skills  
2 enhancement services and making an appropriation.

***Analysis by the Legislative Reference Bureau***

This bill increases the funding during the 2013-15 biennium for grants to community action agencies to provide skills enhancement services to certain low-income individuals.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3 **SECTION 1. Fiscal changes.**

4 (1) COMMUNITY ACTION AGENCIES; SKILLS ENHANCEMENT GRANTS. In the schedule  
5 under section 20.005 (3) of the statutes for the appropriation to the department of  
6 children and families under section 20.437 (2) (fr) of the statutes, as affected by the  
7 acts of 2013, the dollar amount is increased by \$250,000 for the first fiscal year of the  
8 fiscal biennium in which this subsection takes effect to provide funding for skills
