1 AN ACT ^{repeal} to repeal 29.185 (6) (a) 2. and 29.185 (6) (c); to amend 29.888 (1m),
2 29.921 (7) and 29.927 (8); and to create 29.185 (6) (am) of the statutes; relating
3 to: use of dogs in hunting wolves.

Analysis by the Legislative Reference Bureau

Under current law, a wolf harvesting license authorizes the holder to use dogs to track or trail wolves while hunting. This bill prohibits the use of dogs for wolf hunting.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- 4 SECTION 1. 29.185 (6) (a) 2. of the statutes is repealed.
- 5 SECTION 2. 29.185 (6) (am) of the statutes is created to read:
- 6 29.185 (6) (am) *Prohibition against dogs.* No person may use dogs for the
- 7 purpose of hunting wolves.
- 8 SECTION 3. 29.185 (6) (c) of the statutes is repealed.
- 9 SECTION 4. 29.888 (1m) of the statutes is amended to read:
