AN ACT ...; relating to: a sales and use tax exemption for silver and gold. ✓

Analysis by the Legislative Reference Bureau

This bill creates a sales and use tax exemption for the sale of silver and gold. ✓

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill. ✓

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
