2 **1.** Page 32, line 1: after “established.” insert “Up to 50 percent of the election
3 officials at any one polling place may be qualified electors of a county within which
4 the municipality where the election official serves is located, but each chief inspector
5 shall be a qualified elector of the municipality in which the chief inspector serves.
6 If no qualified candidate for chief inspector is available or if the chief inspector is
7 appointed to fill a vacancy under par. (b), the person so appointed need not be a
8 qualified elector of the municipality.”.

9 **2.** Page 32, line 7: delete “municipality county” and substitute “municipality”.

10 **3.** Page 32, line 9: delete “municipal county” and substitute “municipal”.
