

**INSERT 2.1:**

**SECTION 1.** 951.02 of the statutes is amended to read:

**951.02 Mistreating animals.** No person may treat any animal, whether belonging to the person or another, in a cruel manner. This section does not prohibit normal and accepted veterinary practices, and, in the case of farm animals A  
this section does not impose requirements or standards more stringent than normally accepted animal husbandry practices.
