Chad and Hariah,

In reviewing AB 689, I noticed what appears to be a drafting error. On page 4, lines 4-5, GAB is required to post online the number of notices that were returned to the board (GAB) requesting continuation of registration. However, under the bill, an elector who requests continuation of his or her registration returns a statement to his or her municipal clerk, not GAB. I discussed this with the drafter, and we agree that it would be best to delete the language "to the board" in that provision. If you want to draft an amendment that makes this change, please let Tracy Kuczenski (at LRB) or me know.
