

This bill increases funding for the Wisconsin School Day Milk Program by \$68,600 in the 2012-13 fiscal year.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 **SECTION 1. Fiscal changes.**

3 (1) In the schedule under section 20.005 (3) of the statutes for the appropriation
4 to the department of public instruction under section 20.255 (2) (cp) of the statutes,
5 as affected by the acts of 2011, *2013* the dollar amount is increased by \$68,600
6 second fiscal year of the fiscal biennium in which this subsection takes effect to
7 increase funding for the purpose for which the appropriation is made.
