WHEREAS, Andrew was born on August 28, 1986, in Green Bay to Douglas and Nicole Steiner, and died on January 27, 2013, outside of Green Bay while assisting at the sight of a motor vehicle crash; and

WHEREAS, Andrew was a 2004 graduate of Bay Port High School in Suamico, Wisconsin, and was a student at Northeast Wisconsin Technical College, and Andy proudly joined the United States Army on August 16, 2006, and served tours overseas in Kuwait, from August 2007 to May 2008 and Afghanistan, from May 2011 to June 2012; and

WHEREAS, Andrew was promoted to the rank of sergeant on December 1, 2011, and embodied the Army's core values of loyalty, duty, respect, selfless service, honor, integrity, and personal service; and

WHEREAS, Andrew received numerous military awards including the following: Afghanistan Campaign Medal with Campaign Star, Army Commendation Medal with Oak Leaf Cluster, Army Good Conduct Medal, Army Reserve Component Achievement Medal, National Defense Service Medal, Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, Army Service Ribbon, Overseas Service Ribbon with numeral 2, Army Reserve Component Overseas Training Ribbon, Armed Forces Reserve Medal, and the NATO Medal; and

WHEREAS, Andrew was the beloved son of Douglas and Nicole Steiner; brother to Samantha DuBois, brother-in-law to Joshua DuBois, Uncle to Emma DuBois, brother to Kevin Armstrong and brother to Lyssa Steiner; and

WHEREAS, Andrew will be sorely missed, but his memory will live on. He will forever be remembered as having passed away the way he lived – serving others. His sacrifice and service to others are an example to us all.
