

Whereas, Tucker Fredricks, a native of Janesville, Wisconsin, has secured a position on the United States Olympic Long Track Speedskating Team for a third consecutive Olympic Games; and

Whereas, Tucker Fredricks, born in Janesville in 1984, will seek to become the third straight American to win the Olympic 500 meters event when he competes in the games at Sochi, Russia; and

Whereas, Tucker Fredricks, the son of Dan and Shawn Fredricks of Janesville, finished 24<sup>th</sup> at the Olympic 2006 Games in Turin, Italy, and 12<sup>th</sup> in the games in 2010 Vancouver, Canada; and

Whereas, Tucker Fredricks is a two-time national champion who won the overall World Cup title in the 500 meters in 2007 and again in 2010 and took bronze in his event in the 2007 World Single Distance Championships and has earned 31 World Cup medals in the 500, including 12 gold, six silver and 13 bronze since 2002; and

Whereas, Tucker Fredricks, a 2002 graduate of Joseph A. Craig High School in Janesville, Wisconsin, holds the national record time in the 500 meters;
