1 AN ACT *to amend* 977.08 (4m) (c); and *to create* 977.08 (4m) (d) of the statutes;
2 **relating to:** increasing the rate paid to private attorneys for representing
3 indigent clients.

Analysis by the Legislative Reference Bureau

Under current law, the state public defender (SPD) provides legal representation for indigent persons in criminal, delinquency, and certain related cases. The SPD assigns cases either to staff attorneys or to local private attorneys. Generally, a private attorney who is assigned a case by the SPD is paid \$40 per hour for time spent related to the case and \$25 per hour for time spent in travel in certain situations.

This bill increases to \$75 per hour the amount a private attorney is paid for time spent related to the case.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 located or if the trip requires traveling a distance of more than 30 miles, one way,

12 per hour for time spent in travel related to a case if any portion of the trip is outside
13 the county in which the attorney's principal office is located or if the trip requires
14 traveling a distance of more than 30 miles, one way, from the attorney's principal
15 office.
