If possible, getting this by end of day is ideal.



2 **1.** Page 6, line 23: delete lines 23 and 24.

3 **2.** Page 9, line 13: after "later than" insert "60 days after".

4 **3.** Page 9, line 14: delete "under this par. (b)" and substitute "under par. (c)".

5 **4.** Page 11, line 4: delete "48 consecutive months" and substitute "24
6 consecutive months".

7 (END)
