2 1. Page 2, line 9: delete “\$44.25” and substitute “\$49.25”. ✓

3 2. Page 2, line 14: delete “the members of which are members” and substitute
4 “that is a member”. ✓

5 3. Page 3, line 1: delete “Clubs and that” and substitute “Clubs, that”. ✓

6 4. Page 3, line 6: delete “a member of a snowmobile club” and substitute “both
7 a member of a snowmobile club and a member of the Association of Wisconsin
8 Snowmobile Clubs”. ✓

9 5. Page 3, line 10: delete “is not a member of a snowmobile club” and substitute
10 “does not meet the requirements under subd. 3.”. ✓

11 6. Page 3, line 13: delete that line and substitute “that has a model year that
12 is at least 30 years”. ✓
