- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 5, line 12: delete that line and substitute “shall allocate at least
- 3 \$375,000 annually to programming that meets the”.
- 4 **2.** Page 5, line 13: delete “meet” and substitute “satisfy”.
- 5 **3.** Page 5, line 18: delete “\$750,000” and substitute “\$375,000”.
- 6 **4.** Page 5, line 19: delete “that establish” and substitute “to provide”.
- 7 **5.** Page 5, line 20: after “illnesses.” insert “In the schedule under section
- 8 20.005 (3) of the statutes for the appropriation to the department of justice under
- 9 section 20.455 (2) (em) of the statutes, as affected by the acts of 2013, the dollar
- 10 amount is increased by \$375,000 for the second fiscal year of the fiscal biennium in
- 11 which this subsection takes effect to provide grants for counties to provide
- 12 alternatives to prosecution and incarceration for persons with mental illness.
