



1 **AN ACT** ...; **relating to:** providing proof of residence when registering to vote.

***Analysis by the Legislative Reference Bureau***

Under current law, except for a military elector or an overseas elector, an elector who registers to vote by mail and has not voted previously in an election in this state or an elector who registers after the close of registration must provide proof of residence. Under this bill, except for military and overseas electors, all electors must provide proof of residence to register to vote.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

2 **SECTION 1.** 6.33 (1) of the statutes is amended to read:

3 6.33 (1) The board shall prescribe the format, size, and shape of registration  
4 forms. All forms shall be printed on cards and each item of information shall be of  
5 uniform font size, as prescribed by the board. The municipal clerk shall supply  
6 sufficient forms to meet voter registration needs. The forms shall be designed to  
7 obtain from each applicant information as to name; date; residence location; location  
8 of previous residence immediately before moving to current residence location;

**SECTION 1**

1 citizenship; date of birth; age; the number of a current and valid operator's license  
2 issued to the elector under ch. 343 or the last 4 digits of the elector's social security  
3 account number; whether the applicant has resided within the ward or election  
4 district for at least 28 consecutive days; whether the applicant has been convicted of  
5 a felony for which he or she has not been pardoned, and if so, whether the applicant  
6 is incarcerated, or on parole, probation, or extended supervision; whether the  
7 applicant is disqualified on any other ground from voting; and whether the applicant  
8 is currently registered to vote at any other location. The form shall include a space  
9 for the applicant's signature. Below the space for the signature, the form shall state  
10 "Falsification of information on this form is punishable under Wisconsin law as a  
11 Class I felony.". The form shall include a space to enter the name of any special  
12 registration deputy under s. 6.26 or 6.55 (6) or inspector, municipal clerk, or deputy  
13 clerk under s. 6.55 (2) who obtains the form and a space for the deputy, inspector,  
14 clerk, or deputy clerk to sign his or her name, affirming that the deputy, inspector,  
15 clerk, or deputy clerk has accepted the form. The form shall include a space for entry  
16 of the ward and aldermanic district, if any, where the elector resides and any other  
17 information required to determine the offices and referenda for which the elector is  
18 certified to vote. The form shall also include a space where the clerk may record an  
19 indication of whether the form is received by mail, a space where the clerk may record  
20 an indication of the type of identifying document submitted by the elector as proof  
21 of residence under s. 6.34, ~~whenever required~~, and a space where the clerk, for any  
22 applicant who possesses a valid voting identification card issued to the person under  
23 s. 6.47 (3), may record the identification serial number appearing on the voting  
24 identification card. Each county clerk shall obtain sufficient registration forms for

1 completion by an elector who desires to register to vote at the office of the county clerk  
2 under s. 6.28 (4).


