Whereas, in 2007 David completed his AIT Chaplain Assistant training in Fort Jackson, South Carolina, and was awarded an ROTC scholarship with the Bear Battalion associated with Missouri State University in Springfield, Missouri. David was commissioned as a Second Lieutenant in May 2010. In January 2011, David graduated from the Infantry Basic Officer Leadership Course at Fort Benning, Georgia. He also completed Combatives Level I and II and the Stryker Brigade Combat Team Leader's Course; and

Whereas, David served with distinction in the United States Army 5th Battalion, 20th Infantry Regiment, 3rd Stryker Brigade Combat Team, 2nd Infantry Division, Joint Base Lewis-McChord, Washington; and

Whereas, David embodied the Army's core values of loyalty, duty, respect, selfless service, honor, integrity, and personal courage and he is sorely missed; and
