Mary,

I came up with a few alternatives for the veterans' home language in s. 45.51 (3) (a).

"Physical care" includes skilled rehabilitation services following a hospital discharge. [This option is broader and doesn't really pinpoint the folks on Medicare Part A.]

Or

"Physical care" includes skilled rehabilitation services following a hospital stay that meets the qualifications under 42 CFR 409.30.

You can eliminate the word "skilled" but that is the term that the federal government uses for what Medicare covers.

I hope this helps. If you need more options, let me know.






