YoungStar Five-Star Providers
[LFB Paper #202]

Motion:

Move to require the Department of Children and Families (DCF) to convene, by September 30, 2013, a meeting of all five-star YoungStar child care providers that provide services to more than 50 children who are participating in Wisconsin Shares. Require DCF to hear concerns from these child care providers about YoungStar, reimbursement rates under the Wisconsin Shares program, and other issues. Require DCF to include a summary of these concerns and recommendations for addressing these concerns in the Department's next quarterly YoungStar report to the Joint Committee on Finance.

Note:

This motion would require DCF to meet with five-star child care providers who provide care to more than 50 children participating in the Wisconsin Shares program by September 30, 2013. The purpose of the meeting is for DCF to listen to concerns of these child care providers about providing quality services to Wisconsin Shares children under YoungStar, as well as any other issues, and summarize these concerns, along with recommendations for addressing these concerns, in the Department's next quarterly YoungStar report to the Committee.
