calendar year 2012, so that any additional funding provided for the consortia's' income maintenance activities that exceeds the base funding amount would be distributed to the consortia based on each consortium's caseload. Increase funding DHS allocates to consortia by \$139,200 GPR and \$139,000 FED in 2013-14 and by \$278,500 GPR and \$278,500 FED in 2014-15 to reflect the estimated cost of this partial hold harmless provision, based on the calendar 2013 allocations to the IM consortia.

Under current law [s. 49.78(2)(b)3] of the statutes, DHS is required to reimburse multicounty consortia for the services consortia provide on a risk-adjusted caseload basis. DHS administers this provision by allocating funding based on the total number of cases each consortium manages.
