1 At the locations indicated, amend the engrossed bill as follows:

2 1. Page 9, line 23: delete "~~including any person who~~ provides lobbying
3 services".

4 2. Page 9, line 24: delete that line and substitute "for, or"
5 board, or".

6 3. Page 15, line 2: after that line insert:

7 "SECTION 16e. 59.52 (32) of the statutes is created to read:

8 59.52 (32) RESEARCH DEPARTMENT. In any county with a population of 750,000
9 or more, the board may enact an ordinance creating a department in county
10 government to provide independent and nonpartisan research services for the board
11 and the county executive. The department may not consist of more than 4.0 full-time
12 equivalent positions. Employees of the department shall be hired and supervised by
13 the comptroller, and shall serve at the pleasure of the comptroller. Such a

1 department shall respond to requests for services from the board and the county
2 executive. The authority to create a department under this subsection may not be
3 exercised after the county board enacts its budget for the 2017 fiscal year.”.

4 **4.** Page 17, line 8: after that line insert:

5 “SECTION 21e. 59.53 (24) of the statutes is created to read:

6 59.53 (24) GOVERNMENT RELATIONS. In any county with a population of 750,000
7 or more, if the county has an office of intergovernmental relations or a department
8 or subunit of a department that provides lobbying services for the county, that office,
9 department, or subunit shall employ ~~at least~~ one individual who is responsible for
10 representing the interests of, and reports to, the county executive and ~~at least~~ one
11 individual who is responsible for representing the interests of, and reports to, the
12 county board.”.

13 **5.** Page 18, line 25: after that line insert:

14 “(d) Any costs associated with a department created under s. 59.52 (32).

15 (e) Space rental that is attributable to the county board.”.
