Marc:

I need the following amendments drafted to engrossed AB 85 as simple amendments for Senator Taylor.

1 – Make the provisions of the executive council approval of agreements with municipalities advisory only, remove the binding nature of the exec council decision.

2 – Allow the county to provide access to health benefits for supervisors at no cost to taxpayers

3 – Similar to LRB a0393, embody the county board resolution to allow for the exec and board to each have a lobbyist functioning

4 – Similar to LRB a0392, do not count the cost of rent and IT costs charged to the board against the .04 budget limitation

5 – Replicate LRB a0394/2 for AB 85

6 – Remove the provision of the bill allowing the executive to introduce legislation to the board

7 – Remove provision on signature of contracts, keep current law/practice

8 – We will need an amendment rewording the referendum. I will get you a suggestion.

NOTE – I am gone beginning next Monday (5/13-5/20). Gary Bennett in my office is the contact in my absence on the bill. I have copied him on this request. We expect AB 85 on the floor on Tuesday.



- 1 At the locations indicated, amend the *engrossed* bill as follows:
- 2 **1.** Page 8, line ¹³ 11: delete "A" and substitute "Except for access to a health
3 insurance plan ^{that} which provides benefits to county officers or employees, a".
- 4 **2.** Page 8, line 12: delete "health insurance and".
- 5 **3.** Page 8, line 17: after "census." insert "If the county authorizes a supervisor
6 to obtain coverage under a health insurance plan that is offered to county officers ^{or}
7 employees, the supervisor is responsible for all costs associated with the health
8 insurance ^{plan} and the county may not pay any part of the premiums or other costs that
9 ^{are associated with} enable the supervisor to obtain coverage from such a plan."

Page 8, line 13: after "law" insert "and except for access to a health insurance plan that provides benefits to county officers and or employees"
