- 2 **1.** Page 24, line 4: delete “February 18” and substitute “August 12”.
- 3 **2.** Page 24, line 5: delete the material beginning with “spring” and ending with
- 4 “April 1,” on line 6 and substitute “general election to be held on November 4.”
- 5 **3.** Page 24, line 6: delete “that portion of”.
- 6 **4.** Page 24, line 10: delete “and which” and substitute “which”.
- 7 **5.** Page 24, line 13: after “law” insert “; which changes the compensation
- 8 structure by which a Milwaukee county supervisor may be paid; which changes the
- 9 term length of a Milwaukee county supervisor; which alters the right of an annuitant
- 10 under the Milwaukee County Employees Retirement System to be rehired by
- 11 Milwaukee county; which limits the authority of Milwaukee county to enter into
- 12 certain intergovernmental agreements; which removes and clarifies certain

1 authority of the Milwaukee county board; which increases and clarifies the authority
2 of the Milwaukee county executive; and which deletes obsolete statutory references”.

3 **6.** Page 24, line 17: delete the material beginning with “the portions” and
4 ending with “(a)” on line 18 and substitute “this act”.

5 **7.** Page 24, line 18: delete the material beginning with “the portions” and
6 ending with “(a)” on line 19 and substitute “this act”.

7 **8.** Page 24, line 21: delete “April 1,” and substitute “November 4,”.
