ASSEMBLY AMENDMENT ,
TO ASSEMBLY BILL 27

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 9: delete lines 9 to 14.

3 **2.** Page 3, line 3: delete the material beginning with "there are" and ending
4 with "resources in" on line 4.

5 **3.** Page 3, line 4: after "office" insert "lacks sufficient and appropriate legal and
6 financial resources, which necessitates the need".

7 **4.** Page 3, line 4: after "services." insert "The governor shall consult with the
8 attorney general in making this finding."

9 **5.** Page 3, line 5: before "amount" insert "estimated".

10 **6.** Page 3, line 8: delete that line and substitute:

11 "3. The venue in which the litigation would likely occur."

1 **7.** Page 3, line 12: delete “invite proposals to be submitted unless the governor
2 determines” and substitute “request the department of administration to invite bids
3 to be submitted. The department of administration shall invite bids and shall ensure
4 that the notice of the bidding process contains any pertinent requirements in this
5 section. Following the bidding process, the secretary of administration shall
6 recommend a responsible bidder to the governor, who shall make the final
7 determination. The governor may determine”.

8 **8.** Page 3, line 13: delete “proposals” and substitute “bids”.

9 **9.** Page 3, line 13: delete “sets” and substitute “the governor shall set”.

10 **10.** Page 3, line 14: delete that line.

11 **11.** Page 3, line 16: after “fee” insert “excluding reasonable costs and expenses,
12 as determined by the court with jurisdiction over the action,”.

13 **12.** Page 3, line 18: delete lines 18 to 24 and substitute:

14 “b. If the recovery is at least \$10 million but less than \$15 million, the sum of
15 \$2,500,000 and 20 percent of the amount by which the recovery exceeds \$10 million.

16 c. If the recovery is at least \$15 million but less than \$20 million, the sum of
17 \$3,500,000 and 15 percent of the amount by which the recovery exceeds \$15 million.

18 d. If the recovery is at least \$20 million but less than \$25 million, the sum of
19 \$4,250,000 and 10 percent of the amount by which the recovery exceeds \$20 million.

20 e. If the recovery is at least \$25 million, the sum of \$4,750,000 and 5 percent
21 of the amount by which the recovery exceeds \$25 million.”.

22 **13.** Page 4, line 2: after “expenses” insert “as determined by the court with
23 jurisdiction over the action”.
