1. Clarify that a person gets the discounted fee if the person is a member of a local club and that local club is affiliated with the AWSC
2. Incorporates the items in AA1 but without the supplemental late fee

There was discussion about a request from Rep. Kaufert to put limits on how the AWSC may use the fees that it receives from local clubs. I said that I was concerned about whether the state could tell a private organization that receives private funds how they may spend those funds. Adam said that he understood that this could be a problem and said that he would discuss this issue with Rep. Kaufert. Emily will let me know tomorrow how to proceed with respect to this issue.
