2 1. Page 2, line 21: after "election." insert "Notwithstanding the other
3 provisions of this paragraph, ✓ an individual may make an appointment with the
4 actual city, town, or village clerk, as appropriate, so that, notwithstanding s. 7.21 (1),
5 the clerk, not a member of the clerk's staff or a designated agent, may receive the
6 individual's application made in person after ✓ 7 p.m. or anytime on Saturday or
7 Sunday, not including the Saturday and Sunday ✓ after the Friday preceding the
8 election." ✓
