- ✓ • Deadline for SVDs to submit ballots to muni clerk – “Same day whenever possible, but no later than 18 hours.”
- ✓ • Page 7, line 3 Change “An occupant of the retirement home...” to “An occupant of a retirement home...”
- ✓ • Page 7, line 3 sentence starting with “An occupant of...” move to page 6, line 22.
- ✓ • Section 13, After comma on page 6, line 25: add language similar to “and the municipal clerk or board of election commissioners has decided to not provide SVD service to the retirement home.”
- ✓ • Section 13, on page 7, line3: add language similar to “The municipal clerk or board of election commissioners will give the SVDs dispatched to the facility the list to verify which residents are eligible to utilize the SVD process.”
- ✓ • Switch effective date to May 1, 2014

**1.** Page 6, line 22: after "(b)" insert "An occupant of a retirement home may vote in person at the polling place serving his or her residence or may apply for and cast an absentee ballot at the election in the same manner as provided for other electors of the municipality where he or she resides."

**2.** Page 6, line 25: after "election," insert "and the municipal clerk or board of election commissioners has not elected to dispatch special voting deputies to the retirement home,".

**3.** Page 7, line 3: delete the material beginning with "An" and ending with "resides." on line 6 and substitute "The municipal clerk or board of election commissioners shall then provide the names and addresses to the special voting

1 deputies to verify which residents are eligible to cast their ballots with the special  
2 voting deputies.”.

3 4. Page 12, line 3: delete the material beginning with “When” and ending with  
4 “dispatched.” on line 5 and substitute “As soon as possible after visiting each  
5 residential care facility or retirement home, but not later than 18 hours after the
