

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 9 after "location." insert "The form shall include a space for the
3 applicant to indicate that he or she does not have an identifying document as
4 specified under s. 6.34 (3) (a) and to request that the clerk verify the applicant's
5 residence by mail, as provided under s. 6.34 (3) (d)."

6 2. Page 3, line 20 after "(3)" insert "except as provided under sub. (3) (d)".

7 3. Page 4, line 2 after that line insert:

8 "SECTION 3d. 6.34 (3) (d) of the statutes is created to read:

9 6.34 (3) (d) If an eligible elector is unable to present any identifying document
10 specified under par. (a), the elector may, on the registration form, request that the
11 municipal clerk verify the elector's address by mail, in the manner prescribed by the
12 board. If the clerk is able to verify that the elector's address is correct, and a valid
