- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 11: delete lines 11 to 13.
- 3 **2.** Page 2, line 16: delete “~~dyeing, tinting, coloring, bleaching,~~” and substitute
- 4 “dyeing, tinting, coloring, bleaching, waxing,”.
