1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 6, line 2: delete lines 2 to 16 and substitute:

3 (b) "66.0809 (5) (bm) No earlier than 14 days after receiving a notice under (sub)
4 (5) (b) of a tenant's past-due charges for electric service, the owner of a rental
5 dwelling unit may request that the municipal public utility terminate electric service
6 to the rental dwelling unit. Except as provided under rules of the public service
7 commission relating to disconnection of service and subject to the procedural
8 requirements under those rules, unless all past-due charges are paid, the municipal
9 utility shall terminate electric service to the rental dwelling unit upon receipt of a
10 request under this paragraph."
