

TO SENATE BILL 299**

Today

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 5: after "exemption" insert "no later than September 1 of the  
3 year to which the exemption relates".

4 2. Page 2, line 14: after that line insert:

5 "(am) The county board shall make a decision to approve or disapprove an  
6 application received under par. (a), and notify the applicant of its decision, no later  
7 than 30 days after the date on which it receives the application. If the county board  
8 disapproves an application under par. (a) the town may appeal the county board's  
9 decision to the circuit court of the county."

10 3. Page 2, line 23: delete "2013" and substitute "2014".
