1 **SECTION 3.** 450.01 (16) (hm) of the statutes is created to read:

2 450.01 (16) (hm) Making therapeutic alternate drug selections in accordance
3 with written guidelines or procedures previously established by a quality
4 assessment and assurance committee of a nursing facility under s. 49.498 (2) (a) 3.
5 or by a committee established for a nursing home under s. 50.045 (2), if the use of the
6 therapeutic alternate drug selection has been approved for a patient during the
7 period of the patient's stay within the nursing facility or nursing home by any of the
8 following:

9 1. The patient's personal attending physician.

10 2. The patient's advanced practice nurse prescriber, if the advanced practice
11 nurse prescriber has entered into a written agreement to collaborate with the
12 patient's personal attending physician.

13 3. The patient's physician assistant, if the physician assistant is under the
14 supervision of the patient's personal attending physician.

15 **SECTION 4.** 450.033 of the statutes is created to read:

16 **450.033 Services delegated by physician.** A pharmacist may perform any
17 patient care service delegated to the pharmacist by a physician, as defined in s.
18 448.01 (5).
