Assumptions Used in Arriving at Fiscal Estimate

BILL SUMMARY

This bill establishes a special plate to raise funds for the Amyotrophic Lateral Sclerosis (ALS, also referred to as "Lou Gehrig's Disease") Association. In addition to the regular vehicle registration fee, special group members are required to pay a \$15 fee for issuance or reissuance of the special plates, and a \$25 annual fee that provides funds to the ALS Association, Wisconsin Chapter. Contributions are given to the ALS association after the Transportation Fund retains up to \$23,700 to fund start up costs.

This bill makes a one-time increase to the DMV appropriation of \$23,700 to fund DMV's start-up costs. If the special plates will display any logo or symbol associated with the ALS Association, DOT may not issue these special plates until DOT has obtained authority to use any applicable trademark or service mark associated with the ALS Association on these special plates.

FISCAL IMPACT

The bill makes a one-time increase to the DMV appropriation, and provides that the Transportation Fund retain contributions, up to \$23,700, or actual costs of production, whichever is less, to fund the initial cost.

The estimated production cost to DMV is \$9,000. Costs include approximately \$8,300 for data processing system modifications, and \$700 for graphic design. The cost to create specialty license plates has recently been reduced due to process efficiencies.
