Senate Bill 21. Relating to: state finances and appropriations, constituting the executive budget act of the 2015 legislature. By joint committee on Finance, by request of Governor Scott Walker. **(Report approved by the Governor with partial veto on 7-12-2015. Wisconsin Act 55)**

Senate Bill 434. Relating to: taxes on managed forest lands, eligibility for the managed forest land program, management plans for managed forest land, sale or transfer of managed forest land, productivity of managed forest land, closed managed forest land, forest production areas, natural heritage inventory, wildlife action plans, providing an exemption from emergency rule procedures, and granting rule-making authority. (FE) By Senators Tiffany and Moulton; cosponsored by Representatives Mursau, T. Larson, E. Brooks, Swearingen and Czaja. **(Report approved by the Governor with partial veto on 4-14-2016. Wisconsin Act 358)**

QUESTION: **Shall the bill pass notwithstanding the objections of the Governor?**

(An "Aye" vote will override the Governor's position. A "No" vote will sustain the Governor's position)

Senate Bill 87. Relating to: inspection of certain renovations of one-family and two-family dwellings and requiring the exercise of rule-making authority. (FE) By Senators Roth, Farrow, Nass and LeMahieu; cosponsored by Representatives Kulp, Allen, Jagler, Edming, Murtha, A. Ott and Tittl. **(Report vetoed by the Governor on 4-25-2016)**

Senate Bill 360. Relating to: modifying and repealing various rules promulgated by the Department of Transportation. (FE) By Senators Petrowski and Olsen; cosponsored by Representatives Ripp, Ballweg, Weatherston and Murphy. **(Report vetoed by the Governor on 4-25-2016)**
